Montgomery Antiques & Interiors (MAI), located in Montgomery, Alabama, is hosting the inaugural Camellia Antiques and Interiors Show. IN BENEFIT OF THE LANDMARKS FOUNDATION OF MONTGOMERY:

Landmarks Foundation leads the historic preservation movement in Montgomery through its stewardship of Old Alabama Town (46 buildings owned by the City of Montgomery), its operation of the Old Alabama Town Museum, and its community preservation efforts.

Landmarks began its partnership with the City in 1968 with the purchase and restoration of the 1853 Ordeman-Mitchell-Shaw Townhouse complex, which retains its rare original kitchen and slave quarters. The OMS Townhouse and Slave Quarters is the jewel in our crown of 19th-century buildings, many of which have been moved to Old Alabama Town to save them from demolition and to revitalize the neighborhood north of Madison Ave. Landmarks operate the Old Alabama Town Museum that serves 35,000 visitors annually in the most historic buildings and leases the others to support the stewardship of Old Alabama Town, educational programming, historic preservation advocacy, and community preservation.

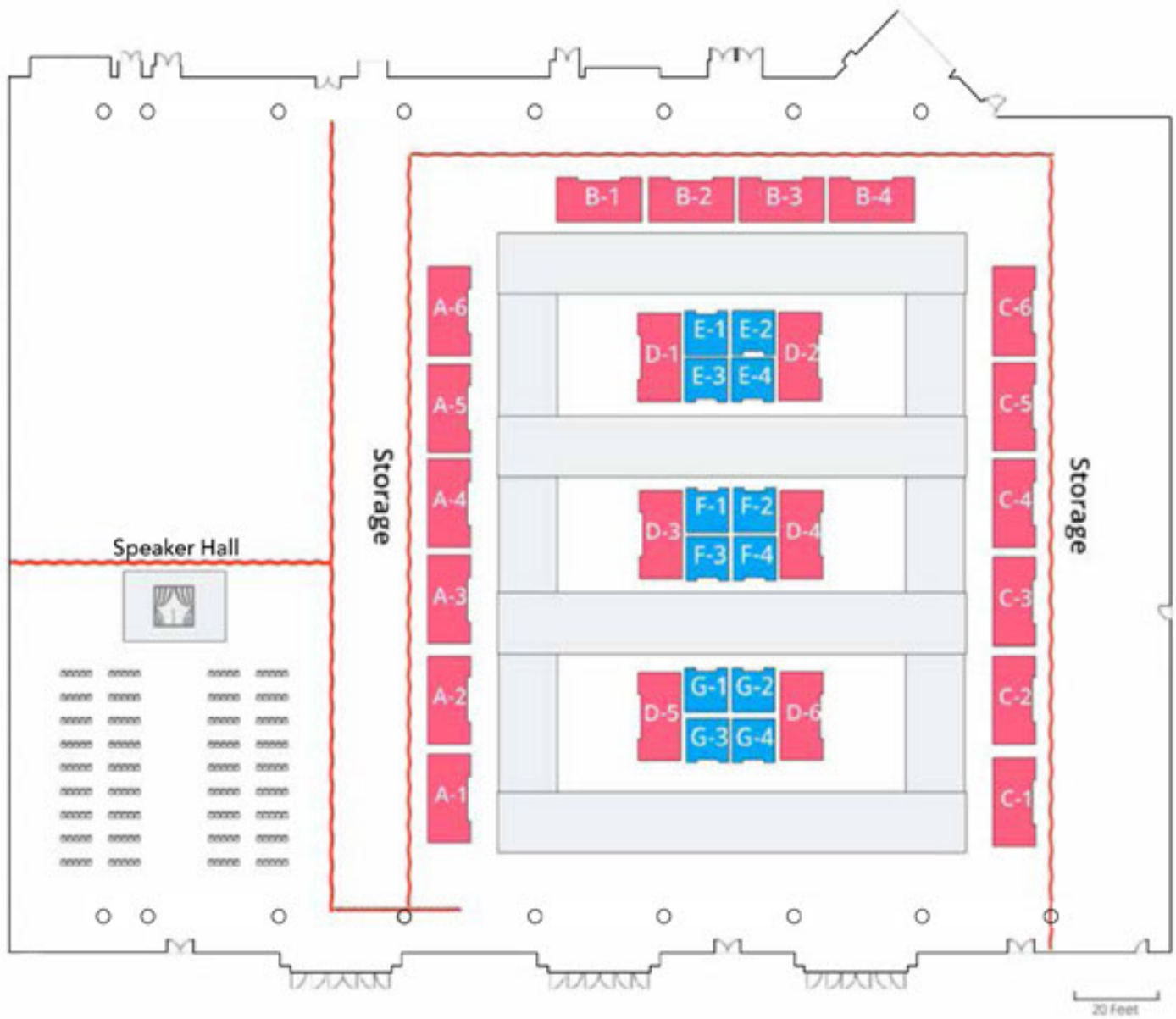
Camellia Antiques & Interiors Show: TENTATIVE FLOOR PLAN*

Terms and Conditions and Show Rules

The Camellia Antiques & Interiors Show is an event organized and managed by Montgomery Antiques and Interiors, LLC, an Alabama limited liability company. For the purpose of this Registration Form and Contract Agreement (the "Contract Agreement"), the organizer shall be referred to as the "Host." The applicant shall be referred to as the "Dealer."

This Contract Agreement is between the Host and the Dealer and is effective on the date that the Dealer's signed Registration Form and Contract Agreement is accepted by the Host.

Agreement: The Dealer agrees to pay the Camellia Antiques and Interiors Show fees, as itemized on page 1, and to comply with all rules and regulations of the show, as itemized on pages 2 and 3. The Host reserves the right to terminate this Contract Agreement at any time if there is a breach of its terms or of any show rules or regulations by the Dealer. If this occurs, no deposits or other show-related fees will be refunded.

Show Location, Dates, and Hours of Operation: The show will be open to the public on Friday and Saturday, March 13 & 14, 2020, from 10:00 a.m. to 7:00 p.m., and Sunday, March 15, 2020, from 11:00 a.m. to 3:00 p.m., at Renaissance Montgomery Hotel & Spa at the Convention Center, 201 Tallapoosa Street, Montgomery, AL 36104. There will be a ticketed preview showing Thursday, March 12, 2020 from 6:30 to 10:00 p.m. The setup period is 10:00 a.m. - 10:00 p.m. on Tuesday and Wednesday, March 10 & 11, and 10:00 a.m. - 5:00 p.m., Thursday, March 12, 2020. The Dealer must have the booth(s) ready for preview showing by 5:00 p.m. on Thursday, March 12, 2020. The Dealer agrees that the booth(s) covered under this Contract Agreement will be open for business and adequately staffed during all scheduled preview and public show hours. The Dealer further agrees not to begin dismantling the booth(s) or packing up merchandise until the show closes, at 3:00 p.m. on Sunday, after which the booth take-down and load-out period is 3:00 p.m.- 8:00 p.m.

Show Booth spaces: The Host will assign spaces to each Dealer on a first-come, first serve basis. The Host will attempt to accommodate all Dealers with an appropriate choice of space(s) based upon the type of merchandise exhibited and individual Dealer space-related requests. The Dealer will be notified of the acceptance or non-acceptance of the booth space reservation within fifteen (15) business days after receiving the Dealer's registration and payment. If the reservation is not accepted, the payment will be refunded to the Dealer in full within fifteen (15) additional business days. Subletting or donation of a show booth space, either partially or in its entirety, is not permitted without the written consent of the Host.

Registration Fee and Minimum Deposit: A minimum deposit of \$150.00 non-refundable registration fee plus one-half of the booth rental fee must accompany the signed Contract Agreement in order to reserve the requested booth space(s) and brochure advertisement. Booth rental fee is refundable if written cancellation is received prior to January 21, 2020. Booth spaces may be subject to reassignment if the full payment balance due is not received by January 1, 2020. No refund will be made if the Dealer is a "no show" at the event. A fee of \$35.00 will be assessed for any check returned as unpayable.

Liability: The Host is not liable for "Act of God" that may result in the cancellation, rescheduling, or modification of the event. It is understood by all parties there will be no delays or refunds due to rain or inclement weather. The maximum liability of Host to each Dealer is the amount paid by each Dealer. The Host is not liable for any cancellation fees, costs or expenses incurred by Dealers for accommodations booked under the courtesy room blocks available to Dealers.

Loss and Damage: The Host is not responsible for the merchandise or any property of the Dealer. Property that may be damaged, stolen, or lost before, during, or after the show is not the responsibility of the Host, its affiliates and agents, or the operators of the venue.

Safety Regulations: The Dealer must comply with all local fire codes, laws, ordinances, and regulations pertaining to health, fire prevention, and public safety. The Dealer agrees that all edges of carpets and rugs will be taped to the floor to prevent tripping hazards.

Signs: All booth signage will be subject to the approval of the Host. The Host encourages use of special signs to highlight the Dealers' products or services. However, in order to maintain the caliber of the show, general discount signs are not allowed. The Host reserves the right to have the Dealer remove signs that are not in keeping with the show's image.

Animals: No animals will be allowed within show booth spaces or at the show venue, unless such is a certified service dog, approved by the Host prior to the show.

Sales Tax: The Dealer must comply with all applicable laws and regulations concerning collection and submission of sales tax, including any local sales taxes, and must cooperate with any tax regulation authority whose jurisdiction encompasses the event.

Brochure Advertisements: Each person or company advertising in the brochure shall provide to the Host no later than the 10th day of January 2020, all text, design, graphics and artwork (the "Copy") for the advertisement in media and file formats acceptable to Host. The Host may reject any Copy if it determines the Copy may be false, misleading, deceptive, offensive to the moral standards of the community, is or may be a violation of an existing or proposed law, or in any manner reflects adversely on the character, integrity or standing of any person or business.
